ORDINANCE NO. 406

ORDINANCE PARKING AND STORAGE OF VEHICLES REQUIRING LICENSES AND STATE INSPECTION IN THE TOWN OF MT. OLIVE, MISSISSIPPI

BE IT ORDAINED by the Mayor and the Board of Aldermen of the Town of Mt. Olive,
...
Mississippi, that:

Vehicles or trailers of any kind or type which require licenses or State inspection stickers, but are without current licenses plates or do not have current State inspection stickers affixed to the vehicle or trailer, shall not be parked or stored on any residentially zoned property other than in completely enclosed buildings, nor shall such vehicles be on public streets.

Section 1: The Mayor and Board of Alderman of the Town of Mt. Olive shall direct the Clerk of the Town to send letters to all persons who have violated this ordinance within the city limits putting them on notice that vehicles are not in compliance with this Ordinance;

Section 2: Failure to comply within a reasonable time period thirty (30) days after notice will result in the Town of Mt. Olive removing said vehicle or trailer and assessing all fees and cost associated to the owner.

Penalty: Any person who violates, neglects or refuses to comply with or who resists the enforcement of any provision of this Ordinance, shall on conviction be fined not more than two hundred fifty dollars (\$250) for each offense or imprisonment for ninety (90) days, or both fine and imprisonment. Each month or part thereof that a violation is permitted to exist shall constitute a separate offense. In addition to the above penalty, the Town may obtain an injunction for the purpose of enforcing the terms of this Ordinance.

Effective Date: This Ordinance shall take effect and be in force as soon as permitted by law.

Ordained, Adopted and Approved by the Mayor and Board of Alderman of the Town of Mt. Olive, Mississippi at a meeting held on the 6^{th} day of December, 2005.
